## FACTS

### WHAT DOES FNB PICAYUNE BANK DO WITH YOUR PERSONAL INFORMATION?

#### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and checking account information
- Credit history and payment history

When you are *no longer* our customer, we continue to share your information as described in this notice.

#### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons FNB Picayune Bank chooses to share; and whether you can limit this sharing.

<b>For non-affiliates to market to you</b>	No	We don't share

##### How does FNB Picayune Bank protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

##### How does FNB Picayune Bank collect my personal information?

We collect your personal information, for example, when you

- open an account or make deposits or withdrawals from account
- pay your bills or apply for a loan
- use your credit or debit card

We also collect your personal information from other, such as credit bureaus, affiliates, or other companies.

Definitions	
<p><b>Affiliates</b></p>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ <i>FNB Picayune Bank has no affiliates.</i></li> </ul>
<p><b>Nonaffiliates</b></p>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ <i>FNB Picayune Bank does not share with non affiliates so they can market to you.</i></li> </ul>
<p><b>Joint marketing</b></p>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>■ <i>FNB Picayune Bank does not jointly market.</i></li> </ul>

FACTS	WHAT DOES FNB PICAYUNE BANK DO WITH YOUR PERSONAL INFORMATION FROM THE MOBILE APPLICATION
Why?	<p>The mobile application requests access to information stored on your device such as location, camera, contacts, or other features you are enrolled in to enrich and simplify your own user experience and improve our services, as well as provide additional security to protect your account.</p> <p>It is important for you to understand that:</p> <ul style="list-style-type: none"> <li>• Before granting access to this information, you will be prompted to give the application that permission.</li> <li>• If you do not wish to grant that permission, you may decline.</li> <li>• If you later change your mind, those permissions can be updated in your device's settings.</li> </ul>
What?	<p>Some examples of information your app will request access to are:</p> <ul style="list-style-type: none"> <li>• Location</li> <li>• Contacts</li> <li>• Camera</li> </ul>
How?	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>The application information is retained in accordance with state and federal record retention laws. Please contact us to determine specific timeframes for your personal stored information and if that information may be deleted.</p>
